Reference is made to the circular (Ref. No.: MSM/004/2020) dated 29 April 2020 regarding Part 1 of the Self-attestation of Compliance Questionnaire (the "Questionnaire") and the circular (Ref. No.: MSM/005/2020) dated 15 May 2020 regarding Part 2 of the Questionnaire.

- Part 1 covers China Connect Rules and Client Margin Requirements. Exchange Participants¹ are required to complete and return Part 1 of the Questionnaire by 12 June 2020.
- Part 2 covers Risk Management and is applicable to Clearing Participants² only. Clearing Participants are required to complete and return Part 2 of the Questionnaire by 26 June 2020.

All Participants are required to submit a duly completed Questionnaire via the Electronic Communication Platform³ (the "ECP") at https://www.ecp.hkex.com.hk/.
