Subject: 2022 Annual Attestation and Inspection Programme

As part of our continuing efforts to promote the compliance culture of our marketplace, we will commence the 2022 Annual Attestation and Inspection Programme (the "Programme") shortly. The Programme, which focuses on participants' compliance with the relevant rules and regulations, comprises two core components: (1) self-attestation of compliance by participants and (2) on-site inspection of selected participants. Details of the Programme can be found on the [HKEX Rule Enforcement webpage](#).

### PROGRAMME'S PRIORITY AREAS

The 2022 Programme will put priority on the following areas:

- China Connect Rules:** Compliance with China Connect Rules in relation to Northbound trading (*applicable to China Connect Exchange Participants and Trade-through Exchange Participants of SEHK*);
- Risk Management:** Measures in place to mitigate various areas of risk such as credit, liquidity, operational, market and financial (*applicable to Clearing Participants<sup>1</sup>*); and
- Clearing Rules Obligations:** Compliance with relevant rules and requirements of the clearing houses (*applicable to Clearing Participants<sup>1</sup> and Custodian Participants<sup>2</sup> only*).

In addition, the self-attestation compliance questionnaire will cover Prescribed Risk Controls for Trading System (*applicable to HKFE Participants and SEHK Stock Options Exchange Participants only*).
