Reference is made to the circular dated 15 December 2022 (Ref. No: MO/DT/344/22). The Last Trading Day of the following stock futures contract of Haidilao shall be 29 December 2022:

**HKATS Series Name: HDAZ2** 

Please be advised that the Final Settlement Price of HDAZ2 will be determined by the official closing price of Haidilao ("P") as quoted by SEHK on the Last Trading Day as stated in the Contract Specifications For Stock Futures Contracts and the open position of HDA as of 29 December will be cash settled by using the Cash Settlement Value as per the Contract Specification.

As the Adjustment Ratio ("AR") could only be determined on 30 December 2022 (i.e. after 29 December 2022), the following cash adjustment will be applied to all open positions on HDAZ2 stock futures contracts as of 29 December 2022:

Number of open contracts x P x (contract multiplier of HDA<sup>2</sup> - contract multiplier of HDB<sup>3</sup>)

The above amount shall be debited/credited from/to Clearing Participants' CCMS collateral account on 3 January 2023.
