- (1) The list of China Connect Securities for trading on the next trading day ("T Day") is normally confirmed one business day before T Day. Should there be any changes in the information provided in this circular, a separate circular will be published by HKSCC.
- (2) China Connect Securities are represented by 6-digit stock codes on the Shenzhen Stock Exchange ("SZSE Stock Code"). The same 6-digit SZSE Stock Codes will be used for trading under Shenzhen -Hong Kong Stock Connect. As CCASS currently adopts a 5-digit stock code system, each SZSE Stock Code will be mapped to a unique 5-digit stock code for use in CCASS ("CCASS Stock Code").
- (3) There are no official English stock short names of China Connect Securities for Shenzhen-Hong Kong Stock Connect. The English stock short names will follow the official English stock long names published by Shenzhen Stock Exchange (<http://www.szse.cn/market/companys/company/index.html>) for China Connect Securities as far as possible in CCASS. English stock short names in CCASS will carry a suffix "+A" and will be for use in CCASS only.
