To assure that safeguards are in place against currency exchange rate risk during the period of holidays from 1 to 8 October 2020 of Shanghai and Shenzhen markets, HKSCC will temporarily adjust the haircut rates for acceptance of HKD or USD as collateral for the early release of China Connect Securities that are Securities-on-hold as follows:
