As set out in the circular dated 12 June 2020 (Reference: <u>CD/CDCO/CCASS/021/2020</u>), Hong Kong Securities Clearing Company Limited (HKSCC) is opening a HKD RTGS account with Hong Kong Monetary Authority (HKMA) for settlement of HKD CCP related payment (i.e. CNS and risk management payment). Subject to the approval of the necessary rule amendments by the Securities and Futures Commission, implementation of the settlement of HKD CCP related payment via HKSCC's HKD RTGS Account with HKMA is tentatively scheduled to take place before early next year.

As part of the implementation, Clearing Participants (CP) are needed to authorise your HKD Designated Bank to effect transfers from your Designated Bank Account to HKSCC RTGS Account for the purposes of HKD money settlement of CCASS transactions following procedures specified below:

- 1) CP shall complete the Direct Debit Authorisation (DDA) with sample as attached;
- 2) CP shall contact your Designated Bank and submit the DDA for countersignature; and
- 3) CP shall then submit the original and duly signed DDA to HKSCC for processing by hand at:

Please note that the DDA must be printed on both sides in A4 sized plain paper.

Since it may take times to prepare the DDA, CP is advised to arrange execution of the DDA as soon as possible and return it to HKSCC **before 16 October 2020 (Friday)**. This is an important step to further progress the account opening with HKMA and cooperation from CP is much appreciated. Any delay in the DDA setup may result in CCP money settlement failure at the time of the implementation of RTGS Account.

Details of the changes in CCASS reports and functions will be provided separately by circular in due course.
