1. No physical yellow application form channel but CCASS EIPO service only

Application channel of physical yellow application form is not available for this IPO.

The process flow of CCASS EIPO service remains the same as other normal IPO cases where CCASS Participants who wish to cause HKSCC Nominees to apply for the Hong Kong Offer Shares are required to give electronic application instructions via CCASS terminal.
