1. Renminbi haircut rate applied to settlement of Marks, Margin and Collateral requirements

Please be advised that pursuant to CCASS Operational Procedures Sections 10.10.1 and 10.10A.1, HKSCC has determined to maintain the haircut rates of RMB as <u>2.6%</u> with settlement currency prescribed in HKD and USD respectively after the close of business on <u>12 April 2021</u>. The haircut rates shall be applied when a Clearing Participant selects HKD or USD to settle Marks, Margin and Collateral requirements with settlement currency in RMB or vice versa. Clearing Participants should make necessary funding arrangements in relation to the adjustment on the haircut rate of RMB.

2. Renminbi haircut rate applied to acceptance of HKD or USD as collateral for the early release of China Connect Securities that are Securities-on-hold

HKSCC has also determined to maintain the haircut rates of acceptance of HKD or USD as collateral for the early release of China Connect Securities that are Securities-on-hold. The RMB haircut rates applied to HKD and USD will be <u>3.1%</u> effective from <u>12 April 2021</u>.
