Subject: Century Entertainment International Holdings Limited (Stock Code: 959) - Proposal of Capital Reorganisation and Change in Board Lot Size

Pursuant to the capital reorganisation proposal of Century Entertainment International Holdings Limited ("CENTURY ENT INT"), every 10 existing shares of HK\$0.20 each ("Existing Share") will be consolidated into 1 share of HK\$2.00 ("Consolidated Share"). Immediately after the Share Consolidation, the par value of each Consolidated Share will be reduced from HK\$2.00 to HK\$0.01 ("New Share") by cancelling the paid-up capital to the extent of HK\$1.99 on each Consolidated Share. Upon the Capital Reorganisation becoming effective, the board lot size for trading will be changed from 2,000 Existing Shares to 10,000 New Shares. Dealings in the New Shares are expected to commence on 3 March 2021.

For the convenience of CCASS Participants, HKSCC will carry out the conversions of actual holdings, transactions (including Settlement Instruction Transaction ("SI Transaction"), Investor Settlement Instruction Transaction ("ISI Transaction") and Compulsory Stock Borrowing Transaction ("CSB Transaction") and/or unsettled stock positions (including Continuous Net Settlement Position ("CNS Position") and Isolated Trade Position ("IT Position") of participants in CCASS to facilitate settlement of both New and Existing Shares in CENTURY ENT INT. A stock conversion schedule is attached herewith as per Appendix I.

The aforesaid conversion process would be carried out in the Depository and Common Nominees System ("DNS") automatically on the scheduled dates. However, for stock positions that remain unsettled between 18 March 2021 and 20 April 2021, the CCASS Participants concerned who need to effect the relevant conversion of their holdings for the purpose of settling their short positions should submit the Parallel Trading Conversion Instruction through CCASS Terminals during the above-mentioned period.

CCASS Participants who wish to deposit shares to or withdraw shares from the CCASS Depository are requested to note the following: -

(A) Deposit Arrangement

 From 5 March 2021 until 20 April 2021, Existing Share certificates representing shares of HK\$0.20 each (blue in colour) will be accepted for deposit under stock code: 2994 (Temp). Effective from 21 April 2021, Existing Share certificates representing shares of HK\$0.20



each will only be accepted for deposit for custody purpose under stock code: 959 (New).

Effective from 17 March 2021, the CCASS Depository will accept deposit of New Share certificates representing shares of HK\$0.01 each (green in colour) under stock code: 959 (New).

- 2. For deposits of both Existing and New Share certificates of CENTURY ENT INT under the same stock code, CCASS Participants are requested to use separate Transfer Deeds and Stock Deposit Forms to cover the Existing and New Share certificates respectively.
- 3. An example on how to complete the Stock Deposit Form in respect of deposits of Existing Shares is given as per Appendix III.

(B) Withdrawal Arrangement

1. With effect from 5 March 2021 until 18 March 2021, the CCASS Depository will only accept withdrawal of shares under the temporary stock code: 2994. If participants' holdings are recorded under stock code: 959, they should apply in writing to the CCASS Depository to convert their holdings to the temporary stock code: 2994 for the purpose of withdrawal.

Upon acceptance of the withdrawal order, the CCASS Depository will effect delivery of either Existing Share certificates representing shares of HK\$0.20 each or New Share certificates representing shares of HK\$0.01 each subject to availability of the two types of share certificates.

2. With effect from 19 March 2021, the CCASS Depository will only accept withdrawal of New Shares under the new stock code: 959. If participants' holdings are recorded under temporary stock code: 2994, they should submit the Parallel Trading Conversion Instruction through CCASS Terminals to convert their holdings to the new stock code: 959 for the purpose of withdrawal.

Detailed schedule for accepting deposits and withdrawals under stock code: 959 or the temporary stock code: 2994 is given as per Appendix II.
