

## 通告 CIRCULAR

Subject: **Delisting of NORTHCOM GROUP CO., LTD.(SZSE Stock Code: 002359)  
(CCASS Stock Code: 72359)**

CCASS Participants are requested to note that NORTHCOM GROUP CO., LTD. (SZSE Stock Code: 002359) (CCASS Stock Code: 72359) (“NORTHCOM GROUP”) has issued an [announcement](#) (Chinese only) on Shenzhen Stock Exchange (“SZSE”) website. It states that the security will enter into a Delisting Arrangement Period (退市整理期) for 30 trading days (the “Delisting Arrangement Period”), i.e. the final period during which NORTHCOM GROUP shares can be traded on SZSE before they are delisted from SZSE.

The Delisting Arrangement Period will commence from 10 June 2021 and trading of NORTHCOM GROUP shares on SZSE will be resumed on the same date. The Delisting Arrangement Period is currently expected to end on 22 July 2021. Afterwards, NORTHCOM GROUP shares will be delisted from SZSE. NORTHCOM GROUP shares are Special China Connect Securities which are eligible for sell only in Northbound trading during the Delisting Arrangement Period.

**For any investor who wishes to sell any NORTHCOM GROUP share through China Connect Service, it may only be able to do so on or before the end of the Delisting Arrangement Period.** Upon completion of the delisting from SZSE, NORTHCOM GROUP shares will be removed from the list of Special China Connect Securities and investors will no longer be allowed to buy or sell NORTHCOM GROUP shares through China Connect Service.

### Cessation of CCASS services after delisting

Pursuant to Rule 502 of the General Rules of CCASS (“CCASS Rules”), NORTHCOM GROUP shares will cease to be Eligible Securities after its delisting from SZSE. HKSCC will thereafter cease to render services in respect of NORTHCOM GROUP shares pursuant to Rule 503 of the CCASS Rules.

As physical withdrawal of NORTHCOM GROUP shares from CCASS is not available, HKSCC will continue to hold NORTHCOM GROUP shares under a dummy Stock Code of 44113 for CCASS Participants in their Stock Account after its delisting. Please note that as HKSCC will cease to provide the services contemplated under the CCASS Rules with respect to NORTHCOM GROUP shares after its delisting from SZSE, notwithstanding any holding of NORTHCOM GROUP shares in a CCASS Participant’s Stock Account, HKSCC shall have no obligation to notify CCASS Participants of any news with regarding to NORTHCOM GROUP or to act on any instruction or communication given or purported to be given with respect to any NORTHCOM GROUP share. In the worst case scenario, a CCASS Participant may never be able to exercise its rights and entitlements accruing to

its NORTHCOM GROUP shares or to dispose of its NORTHCOM GROUP shares after the end of the Delisting Arrangement Period.

CCASS Participants are urged to consider the potential liquidity risk and other limitations as well as restrictions on holding NORTHCOM GROUP shares after the end of the Delisting Arrangement Period and promptly take all necessary actions where appropriate.
