Reference is made to the circular issued by Hong Kong Securities Clearing Company Limited ("HKSCC") on 21 October 2021 (Ref. CD/DNS/CCASS/339/2021). With the implementation of the payment of levies payable by sellers and purchasers of securities to the Financial Reporting Council ("FRC Transaction Levy") on 1 January 2022, HKSCC will implement the CCASS service enhancement in relation to the collection of the FRC Transaction Levy.
