Subject: System Infrastructure Upgrade and Relocation of CCASS Secondary Data Centre

Reference is made to the circular dated 25 June 2021 (CCASS Participants circular reference: CCD/CDCO/CCASS/018/2021; Designated Banks circular reference: CCD/CDCO/CCASS/019/2021). Following the successful completion of the Market Rehearsal, the Infrastructure Upgrade and new Secondary Data Centre ("SDC") will commence in production from Monday, 16 August 2021.

The Infrastructure Upgrade and relocation of SDC ("Upgrade") will be performed by the HKEX and transparent to the market. In order to allow CCASS Participants ("CPs") and Designated Banks ("DBs") to verify their connectivity to CCASS, Report Access Platform (RAP) and NGRM Online after the Upgrade, a Connectivity Test ("CT") will be arranged on Saturday, 14 August 2021. CPs and DBs are strongly recommended to participate in the CT.

Details of the CT are as below:

For better communication on the related activities, CPs and DBs who plan to join the CT are required to provide their designated contact details through "Event" under Client Connect on or before 12 August 2021.

CPs and DBs are strongly recommended to coordinate with their IT teams and/or vendors for necessary preparation for the CT. Moreover, CPs and DBs should secure sufficient operation staff and support from their IT teams and/or vendors at all times during the CT.

After the Upgrade on 16 August 2021, there will be a two-week stabilization period from 16 August 2021 to 27 August 2021 (both days inclusive). In the unlikely event where execution of fallback is required, HKEX will announce the detailed arrangements and suspend CCASS service temporarily.

HKEX would like to take this opportunity to thank for CPs' and DBs' cooperation and participation in this Upgrade.
