Reference is made to the circular dated 12 August 2022 (Reference: [CD/OES/CCASS/031/2022](#)) regarding the trading calendar enhancement under Stock Connect (“the Enhancement”), the Clearing and Settlement arrangement will be adjusted to accommodate the additional Northbound trading days under Stock Connect. The launch of the Enhancement will be in the first half of 2023, subject to regulatory approval. To facilitate China Connect Clearing Participants (“CCCPs”) and Designated Banks (“DBs”) to prepare for the launch of the Enhancement, Hong Kong Securities Clearing Company Limited (“HKSCC”) will arrange 3 webinar briefings in September 2022 to provide an overview of the Enhancement and the Clearing and Settlement arrangement for the additional Northbound trading days.
