## 通告 CIRCULAR

**Subject:** Birmingham Sports Holdings Limited (Stock Code: 2309)  
- Proposal of Share Consolidation and Change in Board Lot Size

Pursuant to the share consolidation proposal of Birmingham Sports Holdings Limited ("BIRMINGHAM SPTS"), every 25 existing shares of HK\$0.01 each ("Existing Share") will be consolidated into 1 consolidated share of HK\$0.25 ("Consolidated Share"). Upon the Share Consolidation becoming effective, the board lot size for trading will be changed from 20,000 Existing Shares to 2,000 Consolidated Shares. Dealings in the Consolidated Shares are expected to commence on 6 February 2023.

For the convenience of CCASS Participants, HKSCC will carry out the conversions of actual holdings, transactions (including Settlement Instruction Transaction ("SI Transaction"), Investor Settlement Instruction Transaction ("ISI Transaction") and Compulsory Stock Borrowing Transaction ("CSB Transaction")) and/or unsettled stock positions (including Continuous Net Settlement Position ("CNS Position") and Isolated Trade Position ("IT Position")) of participants in CCASS to facilitate settlement of both Consolidated Shares and Existing Shares in BIRMINGHAM SPTS. A stock conversion schedule is attached herewith as per Appendix I.

The aforesaid conversion process would be carried out in the Central Clearing and Settlement System automatically on the scheduled dates. However, for stock positions that remain unsettled between 21 February 2023 and 21 March 2023, the CCASS Participants concerned who need to effect the relevant conversion of their holdings for the purpose of settling their short positions should submit the Parallel Trading Conversion Instruction through CCASS Terminals during the above-mentioned period.

CCASS Participants who wish to deposit shares to or withdraw shares from the CCASS Depository are requested to note the following: -

### (A) Deposit Arrangement

1. From 8 February 2023 until 21 March 2023, Existing Share certificates representing shares of HK\$0.01 each (blue in colour) will be accepted for deposit under stock code: 2910 (Temp). Effective from 22 March 2023, Existing Share certificates representing shares of HK\$0.01 each will only be accepted for deposit for custody purpose under stock code: 2309 (New).

Effective from 20 February 2023, the CCASS Depository will accept deposit of Consolidated Share certificates representing shares of HK\$0.25 each (orange in colour) under stock code: 2309 (New).

2. For deposits of both Existing and Consolidated Share certificates of BIRMINGHAM SPTS under the same stock code, CCASS Participants are requested to use separate Transfer Deeds and Stock Deposit Forms to cover the Existing and Consolidated Share certificates respectively.
3. An example on how to complete the Stock Deposit Form in respect of deposits of Existing Shares is given as per Appendix III.

#### **(B) Withdrawal Arrangement**

1. With effect from 8 February 2023 until 21 February 2023, the CCASS Depository will only accept withdrawal of shares under the temporary stock code: 2910. If participants' holdings are recorded under stock code: 2309, they should apply in writing to the CCASS Depository to convert their holdings to the temporary stock code: 2910 for the purpose of withdrawal.

Upon acceptance of the withdrawal order, the CCASS Depository will effect delivery of either Existing Share certificates representing shares of HK\$0.01 each or Consolidated Share certificates representing shares of HK\$0.25 each subject to availability of the two types of share certificates.

2. With effect from 22 February 2023, the CCASS Depository will only accept withdrawal of Consolidated Shares under the new stock code: 2309. If participants' holdings are recorded under temporary stock code: 2910, they should submit the Parallel Trading Conversion Instruction through CCASS Terminals to convert their holdings to the new stock code: 2309 for the purpose of withdrawal.

Detailed schedule for accepting deposits and withdrawals under stock code: 2309 or the temporary stock code: 2910 is given as per Appendix II.



# Each Existing Share certificate of 163 shares of HK\$0.01 each represents 6 Consolidated Shares of HK\$0.25 each, which adds up to 12 Consolidated Shares of HK\$0.25 each.

\* The add up total of the Existing Share quantity of 240,326 shares of HK\$0.01 each divided by 25 amounts to 9,613 Consolidated Shares of HK\$0.25 each. The sum of individual certificate ranges added up to 9,612 Consolidated Shares ( 1,600 + 8,000 + 12 ). The CCASS Participant is requested to insert the difference of 1 share on the "No. of Shares" column to make up the total Consolidated Share quantity from 9,612 to 9,613 for processing by the CCASS Depository.
