Electronic payment methods have improved the efficiency, security and lowered costs for the transfer of funds. Following the widespread usage of electronic payment, HKSCC strongly encourages CCASS participants ("Participants") to use the following digital payment means, instead of physical cheques, for franking services of transfer deed stamp duty:

- (i) Bank transfer via internet<sup>2</sup>
- (ii) Bank transfer via ATM
- (iii) Faster Payment System "FPS"<sup>3</sup>
- (iv) SWIFT<sup>4</sup>
