## 通告 CIRCULAR

**Subject:** Richly Field China Development Limited (Stock Code: 313)  
- Proposal of Share Consolidation and Change in Board Lot Size

Pursuant to the share consolidation proposal of Richly Field China Development Limited ("the Company"), every 20 existing shares of HK\$0.05 each ("Existing Share") will be consolidated into 1 consolidated share of HK\$1.00 ("Consolidated Share"). Upon the Share Consolidation becoming effective, the board lot size for trading will be changed from 50,000 Existing Shares to 25,000 Consolidated Shares.

For the convenience of CCASS Participants, HKSCC will carry out the conversions of actual holdings, transactions (including Settlement Instruction Transaction ("SI Transaction"), Investor Settlement Instruction Transaction ("ISI Transaction") and Compulsory Stock Borrowing Transaction ("CSB Transaction")) and/or unsettled stock positions (including Continuous Net Settlement Position ("CNS Position") and Isolated Trade Position ("IT Position")) of participants in CCASS to facilitate settlement of both Consolidated Shares and Existing Shares of the Company. A stock conversion schedule is attached herewith as per Appendix I.

The aforesaid conversion process would be carried out in the Central Clearing and Settlement System automatically on the scheduled dates. However, for stock positions that remain unsettled between 6 February 2025 and 6 March 2025, the CCASS Participants concerned who need to effect the relevant conversion of their holdings for the purpose of settling their short positions should submit the Parallel Trading Conversion Instruction through CCASS Terminals during the above-mentioned period.

CCASS Participants who wish to deposit shares to or withdraw shares from the CCASS Depository are requested to note the following: -

### (A) Deposit Arrangement

1. From 21 January 2025 until 6 March 2025, Existing Share certificates (grey in colour) will be accepted for deposit under stock code: 2935 (Temp). Effective from 7 March 2025, Existing Share certificates will only be accepted for deposit for custody purpose under stock code: 313 (New).

Effective from 5 February 2025, the CCASS Depository will accept deposit of Consolidated Share certificates (yellow in colour) under stock code: 313 (New).

2. For deposits of both Existing and Consolidated Share certificates of the Company under the same stock code, CCASS Participants are requested to use separate Transfer Deeds and Stock Deposit Forms to cover the Existing and Consolidated Share certificates respectively.
3. An example on how to complete the Stock Deposit Form in respect of deposits of Existing Shares is given as per Appendix III.

### **(B) Withdrawal Arrangement**

1. With effect from 21 January 2025 until 6 February 2025, the CCASS Depository will only accept withdrawal of shares under the temporary stock code: 2935. If participants' holdings are recorded under stock code: 313, they should apply in writing to the CCASS Depository to convert their holdings to the temporary stock code: 2935 for the purpose of withdrawal.

Upon acceptance of the withdrawal order, the CCASS Depository will effect delivery of either Existing Share certificates or Consolidated Share certificates subject to availability of the two types of share certificates.

2. With effect from 7 February 2025, the CCASS Depository will only accept withdrawal of Consolidated Shares under the new stock code: 313. If participants' holdings are recorded under temporary stock code: 2935, they should submit the Parallel Trading Conversion Instruction through CCASS Terminals to convert their holdings to the new stock code: 313 for the purpose of withdrawal.

Detailed schedule for accepting deposits and withdrawals under stock code: 313 or the temporary stock code: 2935 is given as per Appendix II.

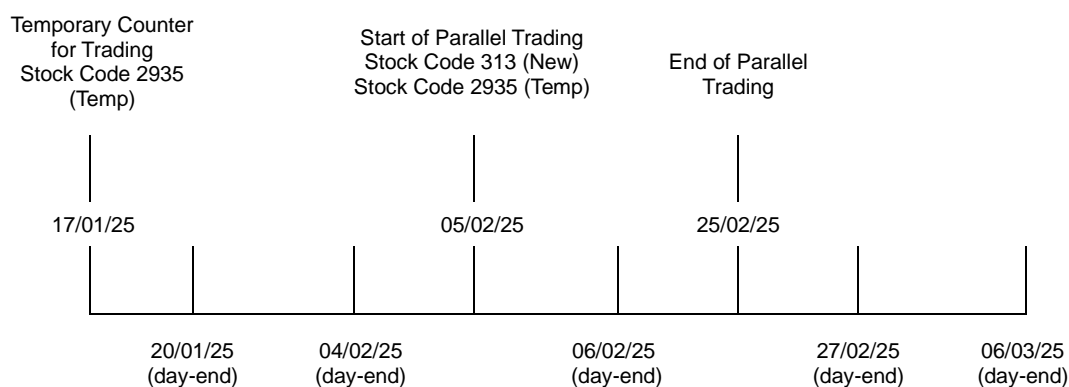
