Subject: 2026 Annual Attestation and Inspection Programme – Self-attestation of Compliance Questionnaire

Reference is made to the circular (Ref. No.: MSM/005/2026) dated 1 April 2026 regarding the Annual Attestation and Inspection Programme 2026 (the “**2026 Programme**”).

Under the 2026 Programme, all Participants¹ are required to submit a duly completed Self-attestation of Compliance Questionnaire (the “Questionnaire”) via the Electronic Communication Platform (the “**ECP**”) at <https://ecp2.hkex.com.hk/>.

The Questionnaire covers the Hong Kong Investor Identification Regime (HKIDR) and two priority areas of the 2026 Programme, namely (1) Trading and Deviated Price Risk Controls and (2) Risk Management. All Participants are required to complete and return the Questionnaire by **7 July 2026**.

Participants are reminded of their obligations under the relevant rules² to complete and return the Questionnaire to the Exchange by the specified deadline. Any late or incomplete submission will be taken seriously and may result in disciplinary actions in accordance with the relevant rules and regulations.
