Further to the circular (reference number: <u>OTCO/013/2020</u>), OTC Clearing Hong Kong Limited (OTC Clear) will launch the products and clearing services of Interest Rate Swaps and Basis Swaps with reference to the below new Floating Rate Options:

- Hong Kong Dollar Overnight Index Average (HONIA)
- Secured Overnight Financing Rate (SOFR)
- Effective Federal Funds Rate (FedFund)
- Euro Short Term Rate (€STR)

OTC Clear will update the stress testing framework to incorporate additional scenarios relevant to the new products. The updated stress scenarios will be applied in the assessment and determination of the Rates and FX Guarantee Fund size.

OTC Clear will update the Liquidity Risk Multipliers to cover the new products. The levels of Liquidity Risk Multipliers are determined based on the results from a poll recently conducted with Clearing Members. The following tables summarized the updated Liquidity Risk Multipliers which will be effective from 6 July 2020.
