Pursuant to the capital reorganisation timetable issued by China Eco-Farming Limited ("China Eco-Farming"), the capital reorganisation which comprises the share consolidation of 10 shares of HK\$0.02 each in China Eco-Farming into 1 consolidated share of HK\$0.2 each and the capital reduction of nominal value of the consolidated shares from HK\$0.2 each to HK\$0.01 each will become effective on 16 November 2018.

Amongst other terms and conditions, China Eco-Farming's capital reorganisation is subject to the passing of relevant resolution(s) to approve the capital reorganisation at the Special General Meeting to be held on 15 November 2018.
