Pursuant to the capital reorganisation timetable issued by Moody Technology Holdings Limited ("Moody Technology"), the capital reorganisation which comprises the share consolidation of 10 shares of HK\$0.10 each in Moody Technology into 1 consolidated share of HK\$1.00 each and the capital reduction of nominal value of the consolidated shares from HK\$1.00 each to HK\$0.01 each will become effective on 19 June 2019. Shareholders, investors and market participants should read the Moody Technology's circulars and regulatory announcements in full including the terms and conditions of Moody Technology's capital reorganisation in dealing with Moody Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Moody Technology's OTP-C temporary stock page (stock code: 2909) on 19 June 2019. Calculation of the Adjusted Previous Closing Price will be based on Moody Technology's closing price on 18 June 2019 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
