Pursuant to the share consolidation timetable issued by Future World Financial Holdings Limited ("Future World Financial"), the share consolidation of 20 shares of HK\$0.001 each in Future World Financial into 1 consolidated share of HK\$0.02 each will become effective on 3 July 2020. Shareholders, investors and market participants should read the Future World Financial's circulars and regulatory announcements in full including the terms and conditions of Future World Financial's share consolidation in dealing with Future World Financial's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Future World Financial's OTP-C temporary stock page (stock code: 2915) on 3 July 2020. Calculation of the Adjusted Previous Closing Price will be based on Future World Financial's closing price on 2 July 2020 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
