Pursuant to the share consolidation timetable issued by China Automotive Interior Decoration Holdings Limited ("China Automotive Interior Decoration"), the share consolidation of 5 shares of HK\$0.005 each in China Automotive Interior Decoration into 1 consolidated share of HK\$0.025 each will become effective on 30 September 2020. Shareholders, investors and market participants should read the China Automotive Interior Decoration's circulars and regulatory announcements in full including the terms and conditions of China Automotive Interior Decoration's share consolidation in dealing with China Automotive Interior Decoration's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Automotive Interior Decoration's OTP-C temporary stock page (stock code: 2952) on 30 September 2020. Calculation of the Adjusted Previous Closing Price will be based on China Automotive Interior Decoration's closing price on 29 September 2020 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
