Pursuant to the share consolidation timetable issued by Wai Chun Bio-Technology Limited ("Wai Chun Bio-Technology"), the share consolidation of 10 shares of HK\$0.0025 each in Wai Chun Bio-Technology into 1 consolidated share of HK\$0.025 each will become effective on 27 November 2020. Shareholders, investors and market participants should read the Wai Chun Bio-Technology's circulars and regulatory announcements in full including the terms and conditions of Wai Chun Bio-Technology's share consolidation in dealing with Wai Chun Bio-Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Wai Chun Bio-Technology's OTP-C temporary stock page (stock code: 2971) on 27 November 2020. Calculation of the Adjusted Previous Closing Price will be based on Wai Chun Bio-Technology's closing price on 26 November 2020 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
