Pursuant to the capital reorganisation timetable issued by InvesTech Holdings Limited ("InvesTech Holdings"), the capital reorganisation which comprises the share consolidation of 20 existing shares of US\$0.02 each in InvesTech Holdings into 1 consolidated share of US\$0.40 each and the capital reduction of nominal value of the consolidated shares from US\$0.40 each to US\$0.01 each will become effective on 28 July 2021. Shareholders, investors and market participants should read the InvesTech Holdings' circulars and regulatory announcements in full including the terms and conditions of InvesTech Holdings' capital reorganisation in dealing with InvesTech Holdings' shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of InvesTech Holdings' OTP-C temporary stock page (stock code: 2957) on 28 July 2021. Calculation of the Adjusted Previous Closing Price will be based on InvesTech Holdings' closing price on 27 July 2021 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
