Pursuant to the share consolidation timetable issued by Greatwalle Inc. ("Greatwalle"), the share consolidation of 5 existing shares of HK\$0.01 each in Greatwalle into 1 consolidated share of HK\$0.05 each will become effective on 2 August 2021. Shareholders, investors and market participants should read the Greatwalle's circulars and regulatory announcements in full including the terms and conditions of Greatwalle's share consolidation in dealing with Greatwalle's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Greatwalle's OTP-C temporary stock page (stock code: 8551) on 2 August 2021. Calculation of the Adjusted Previous Closing Price will be based on Greatwalle's closing price on 30 July 2021 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
