Subject: HONG KONG INVESTOR IDENTIFICATION REGIME (HKIDR) - REPORTING

FORM SUBMISSION DURING END-TO-END (E2E) TEST

With reference to the Exchange circulars (Ref. No.: CT/021/22, CT/026/22 and CT/030/22), all Relevant Regulated Intermediaries (RRIs)<sup>2</sup> are reminded that the E2E Test Session for HKIDR (including two new features of the Orion Central Gateway – Securities Market) will be held from **16 May 2022 to 15 July 2022**. All RRIs are required to participate in the E2E Test Session and are reminded to refer to the published test packages and connectivity guide to get ready for the mandatory testing.

## Submission of Reporting Forms during E2E Test Session

Given that RRIs may encounter difficulties in linking up testing trading data to the relevant reporting forms<sup>3</sup> during the E2E Test, RRIs should note that they simply need to ensure that at least one record have passed the 2nd level validation (i.e. format validation) and that they are able to receive a returned response file of the relevant reporting form in order to be considered as having successfully completed testing on the submission of that reporting form. For the avoidance of doubt, the subsequently processed result of the records contained in the result file will not be used for determining the test result. RRIs are also reminded that they can refer to the HKIDR web corner for templates of the reporting forms that they can use or refer to Section 3 of the File Interface Specifications when preparing the reporting forms.
