

Guidelines for the Migration of Additional Submission and Download Folders in ECP 2.0

A. Cutover Time

Non LOPR Folders

The folders listed in Section B (except LOP folders) will be enabled in ECP 2.0 at around 10pm on 2 December 2022 (Friday).

Same folders will be disabled and hidden in the existing ECP at around 10pm on 2 December 2022 (Friday).

LOPR Folders

LOPR folders will be enabled in ECP 2.0 at around 10pm on 2 December 2022 (Friday). Same folders will still be available in the existing ECP and DCASS RAP during the period from 10pm on 2 December (Friday) to 10pm on 9 December 2022 (Friday) ("transition period"). LOPR submitters can submit files through any one of the platforms during the transition period for LOPR for trade dates from 2 December 2022 to 8 December 2022.

From 10pm on 9 December (Friday) onwards, all LOPR submission shall be submitted through ECP 2.0.
