Pursuant to the capital reorganisation timetable issued by Samson Paper Holdings Limited ("Samson Paper"), the capital reorganisation which comprises the capital reduction of nominal value of the existing shares from HK\$0.10 each in Samson Paper to HK\$0.005 each and the share consolidation of 10 shares of HK\$0.005 each into 1 consolidated share of HK\$0.05 each will become effective on 26 January 2022. Shareholders, investors and market participants should read the Samson Paper's circulars and regulatory announcements in full including the terms and conditions of Samson Paper's capital reorganisation.
