Pursuant to the timetable issued by DL Holdings Group Limited (“DL Holdings”) for the final dividend and bonus issue of shares (the “Dividend and Bonus Issue”), DL Holdings’ shares (stock code 1709) will be marked “ex-all” on 23 September 2022, the Ex-All Date. Shareholders, investors and market participants should read DL Holdings’ regulatory announcements and circulars in full including the terms and conditions of the Dividend and Bonus Issue in dealing with DL Holdings’ shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-dividend and ex-bonus issue (“Ex-All”) and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of DL Holdings’ OTP-C stock page on 23 September 2022, the Ex-All Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on DL Holdings’ closing price on 22 September 2022 (i.e. last cum-all trading day) and by using the following standard adjustment formula for dividend and bonus issue generally.

Adjustment Formula:

Adjusted Previous Closing Price
= $[(\text{Closing Price on the last cum-all trading day} - D) \times Y] \div (X + Y)$

where:

D = Final Dividend per share, i.e. HK\$0.014

X = Number of bonus shares a shareholder is expected to receive when he/she holds Y existing shares on the record date, i.e. 1 bonus share

Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to X bonus shares, i.e. 60 shares

For illustration purpose, depending on DL Holdings' closing price on 22 September 2022, the Exchange shall base on the above standard formula for dividend and bonus issue generally to calculate and display the Adjusted Previous Closing Price on DL Holdings' OTP-C stock page on 23 September 2022 as follows:-
