Pursuant to the timetable issued by Legendary Group Limited (“Legendary Group”) for the bonus issue of shares (the “Bonus Issue”), Legendary Group’s shares (stock code 8195) will be marked “ex-bonus issue” on 30 November 2022, the Ex-Bonus Date. Shareholders, investors and market participants should read the Legendary Group’s regulatory announcements and circulars in full including the terms and conditions of the Bonus Issue in dealing with Legendary Group’s shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-bonus issue and for reference only, an Adjusted Previous Closing Price will be displayed in the “PRV CLOSE” field of Legendary Group’s OTP-C stock page on 30 November 2022, the Ex-Bonus Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on Legendary Group’s closing price on 29 November 2022 (i.e. last cum-bonus trading day) and by using the following standard adjustment formula for bonus issue generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= (Closing Price on the last cum-bonus trading day x Y) ÷ (X + Y)

where:

- X = Number of bonus shares a shareholder is expected to receive when he/she holds Y existing shares on the record date, i.e. 1 bonus share  
Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to X bonus shares, i.e. 10 shares

For illustration purpose, depending on Legendary Group's closing price on 29 November 2022, the Exchange shall base on the above standard formula for bonus issue generally to calculate and display the Adjusted Previous Closing Price on Legendary Group's OTP-C stock page on 30 November 2022 as follows:-
