BROKER-TO-CLIENT ASSIGNED NUMBER (BCAN) FILE SUBMISSION AND DOWNLOAD FUNCTIONS TO ELECTRONIC COMMUNICATION PLATFORM

With reference to the Exchange Circular (Ref. No.: CT/056/23), a majority of China Connect Exchange Participants (CCEPs) and Trade-through Exchange Participants (TTEPs) have successfully completed the mandatory Practice Session (PS1) for migration of NB BCAN file submission and download functions to ECP (the Migration) on 13 May 2023 (Saturday). In order to ensure a smooth production migration, an additional Practice Session (PS2) will be arranged on 20 May 2023 (Saturday) for CCEPs and TTEPs to further verify their system readiness.

The PS2 is mandatory for CCEPs and TTEPs who did not successfully complete the PS1, while it is optional for those who have declared their readiness in the PS1. CCEPs and TTEPs who will participate in the PS2 are required to take the following actions accordingly.
