Pursuant to the rights issue timetable issued by Bossini International Holdings Limited ("Bossini"), Bossini's shares (stock code 592) will be marked "ex-rights" on 23 March 2023, the Ex-Rights Date. Shareholders, investors and market participants should read the Bossini's announcements and prospectus documents in full including the terms and conditions of the rights issue of Bossini in dealing with Bossini's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-rights issue and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Bossini's OTP-C stock page on 23 March 2023, the Ex-Rights Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on Bossini's closing price on 22 March 2023 (i.e. last cum-rights trading day) and by using the following standard adjustment formula for rights issue generally.

### Adjustment Formula:

Adjusted Previous Closing Price = [(Closing Price on the last cum-rights trading day x Y) + (S x X)]  $\div$  (X + Y)

### where:

- S = Subscription price per rights share, i.e. HK\$0.37
- X = Number of rights shares a shareholder is entitled to subscribe when he/she holds Y existing shares on the record date, i.e. 1 rights share
- Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to subscribe for X rights shares, i.e. 2 shares

Note: Price adjustment for rights issue will not be made and the previous closing price will remain unchanged on ex-rights date when the subscription price is higher than the closing price of the shares on the last cum-rights trading day.
