Pursuant to the rights issue timetable issued by China Medical & HealthCare Group Limited ("China Medical & HealthCare"), China Medical & HealthCare's shares (stock code 383) will be marked "ex-rights" on 15 May 2023, the Ex-Rights Date. Shareholders, investors and market participants should read the China Medical & HealthCare's announcements and prospectus documents in full including the terms and conditions of the rights issue of China Medical & HealthCare in dealing with China Medical & HealthCare's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-rights issue and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Medical & HealthCare's OTP-C stock page on 15 May 2023, the Ex-Rights Date. The unadjusted previous closing price will instead be displayed in the free text field. Calculation of the Adjusted Previous Closing Price will be based on China Medical & HealthCare's closing price on 12 May 2023 (i.e. last cum-rights trading day) and by using the following standard adjustment formula for rights issue generally.

Adjustment Formula:

Adjusted Previous Closing Price

$$= [(Closing Price on the last cum-rights trading day \times Y) + (S \times X)] \div (X + Y)$$

where:

S = Subscription price per rights share, i.e. HK\$0.88

X = Number of rights shares a shareholder is entitled to subscribe when he/she holds Y existing shares on the record date, i.e. 1 rights share

Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to subscribe for X rights shares, i.e. 2 shares

Note: Price adjustment for rights issue will not be made and the previous closing price will remain unchanged on ex-rights date when the subscription price is higher than the closing price of the shares on the last cum-rights trading day.
