Pursuant to the rights issue timetable issued by Rare Earth Magnesium Technology Group Holdings Limited ("Rare Earth Magnesium Technology"), Rare Earth Magnesium Technology's shares (stock code 601) will be marked "ex-rights" on 13 September 2023, the Ex-Rights Date. Shareholders, investors and market participants should read the Rare Earth Magnesium Technology's announcements and prospectus documents in full including the terms and conditions of the rights issue of Rare Earth Magnesium Technology in dealing with Rare Earth Magnesium Technology's shares. Adjustment Formula:

Adjusted Previous Closing Price = [(Closing Price on the last cum-rights trading day x Y) + (S x X)] \div (X + Y)

where:

- S = Subscription price per rights share, i.e. HK\$0.08
- X = Number of rights shares a shareholder is entitled to subscribe when he/she holds Y existing shares on the record date, i.e. 1 rights share
- Y = Number of existing shares a shareholder has to hold on the record date for entitling him/herself to subscribe for X rights shares, i.e. 2 shares

Note: Price adjustment for rights issue will not be made and the previous closing price will remain unchanged on ex-rights date when the subscription price is higher than the closing price of the shares on the last cum-rights trading day.
