Pursuant to the share consolidation timetable issued by Talent Property Group Limited ("Talent Property"), the share consolidation of 20 existing shares of HK\$0.004 each in Talent Property into 1 consolidated share of HK\$0.08 each will become effective on 13 September 2023. Shareholders, investors and market participants should read the Talent Property's circulars and regulatory announcements in full including the terms and conditions of Talent Property's share consolidation in dealing with Talent Property's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Talent Property's OTP-C temporary stock page (stock code 2971) on 13 September 2023. Calculation of the Adjusted Previous Closing Price will be based on Talent Property's closing price on 12 September 2023 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

### Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

#### where:

R = Ratio of Share Consolidation, i.e. 20/1
