Pursuant to the share consolidation timetable issued by Good Fellow Healthcare Holdings Limited ("Good Fellow"), the share consolidation of 5 existing shares of HK\$0.01 each in Good Fellow into 1 consolidated share of HK\$0.05 each will become effective on 13 September 2023. Shareholders, investors and market participants should read the Good Fellow's circulars and regulatory announcements in full including the terms and conditions of Good Fellow's share consolidation in dealing with Good Fellow's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Good Fellow's OTP-C temporary stock page (stock code 8598) on 13 September 2023. Calculation of the Adjusted Previous Closing Price will be based on Good Fellow's closing price on 12 September 2023 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
