Pursuant to the capital reorganisation timetable issued by Champion Technology Holdings Limited ("Champion Technology"), the capital reorganisation which comprises the share consolidation of 4 existing shares of HK\$0.01 each in Champion Technology into 1 consolidated share of HK\$0.04 each and the capital reduction of nominal value of the consolidated shares from HK\$0.04 each to HK\$0.01 each will become effective on 19 March 2024. Shareholders, investors and market participants should read the Champion Technology's circulars and regulatory announcements in full including the terms and conditions of Champion Technology's capital reorganisation in dealing with Champion Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Champion Technology's OTP-C temporary stock page (stock code 2929) on 19 March 2024. Calculation of the Adjusted Previous Closing Price will be based on Champion Technology's closing price on 18 March 2024 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 4/1
