Pursuant to the share consolidation timetable issued by Solartech International Holdings Limited ("Solartech International"), the share consolidation of 20 existing shares of HK\$0.01 each in Solartech International into 1 consolidated share of HK\$0.20 each will become effective on 15 April 2024. Shareholders, investors and market participants should read the Solartech International's circulars and regulatory announcements in full including the terms and conditions of Solartech International's share consolidation in dealing with Solartech International's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Solartech International's OTP-C temporary stock page (stock code 2940) on 15 April 2024. Calculation of the Adjusted Previous Closing Price will be based on Solartech International's closing price on 12 April 2024 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 20/1
