Pursuant to the share consolidation timetable issued by CNC Holdings Limited ("CNC Holdings"), the share consolidation of 100 existing shares of HK\$0.001 each in CNC Holdings into 1 consolidated share of HK\$0.1 each will become effective on 19 June 2024. Shareholders, investors and market participants should read the CNC Holdings's circulars and regulatory announcements in full including the terms and conditions of CNC Holdings's share consolidation in dealing with CNC Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of CNC Holdings's OTP-C temporary stock page (stock code 8588) on 19 June 2024. Calculation of the Adjusted Previous Closing Price will be based on CNC Holdings's closing price on 18 June 2024 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

#### Adjustment Formula:

Adjusted Previous Closing Price  
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 100/1

For illustration purpose, depending on CNC Holdings's closing price on 18 June 2024, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on CNC Holdings's OTP-C temporary stock page on 19 June 2024 as follows:-
