Pursuant to the capital reorganisation timetable issued by Tesson Holdings Limited ("Tesson Holdings"), the capital reorganisation which comprises the share consolidation of 10 existing shares of HK\$0.1 each in Tesson Holdings into 1 consolidated share of HK\$1.0 each and the capital reduction of nominal value of the consolidated shares from HK\$1.0 each to HK\$0.1 each will become effective on 17 December 2024. Shareholders, investors and market participants should read the Tesson Holdings's circulars and regulatory announcements in full including the terms and conditions of Tesson Holdings's capital reorganisation in dealing with Tesson Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Tesson Holdings's OTP-C temporary stock page (stock code 2926) on 17 December 2024. Calculation of the Adjusted Previous Closing Price will be based on Tesson Holdings's closing price on 16 December 2024 (i.e. the day immediately before the capital reorganisation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Capital Reorganisation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
