Subject: **Regular OTP-C and OTP-CSC Rehearsal for System Recovery under
Emergency Situation on 7 September 2024**

Exchange Participants (“EPs”) are advised that a regular OTP-C and OTP-CSC rehearsal for system recovery under emergency situation (the “Rehearsal”) will be conducted on Saturday, 7 September 2024 between 11:00am and 3:10pm.

The objective of the Rehearsal is to enable EPs and related parties to familiarize themselves with contingency procedures and related operational matters upon simulated service outage in the HKEX primary data center and restart of various HKEX systems at the secondary data center. All EPs and related parties are cordially invited to participate in the Rehearsal.

The Rehearsal will cover the system recovery mode “Activate OTP-C and OTP-CSC Backup System after TKO Data Center site failover to backup site during the Continuous Trading Session” under emergency situation. During the Rehearsal, all production trading devices in EP’s offices which are subscribed for trading purpose and connected to OTP-C or OTP-CSC will be available for use from 11:00am.

EPs rely on market datafeed vendors for providing price updates on their trading screens should liaise with their respective market datafeed vendors for providing the services during the Rehearsal.

Before the Rehearsal, EPs are required to complete and submit the “Notification Form for Participation in 2024 Market Rehearsal” form ([Attachment 1](#)) to Trading Department of HKEX through Electronic Communication Platform (ECP) on or before 30 August 2024.

EPs are advised to follow the guidelines set out in [Attachment 2](#) during the Rehearsal.

After completion of the Rehearsal, EPs are required to complete and submit the “Rehearsal Evaluation Reply” Form ([Attachment 6](#)) to Trading Department of HKEX through Electronic Communication Platform (ECP) during 9 to 11 September 2024.
