Subject: **Download and Upgrade of Google Chrome Browser for HKATS Online and HKATS Risk Functions**

Currently, the official supporting browser for HKATS Online and HKATS Risk Functions is Google Chrome version **130.0.6723.117** ("Current Version").

To align with the update of Google Chrome, Exchange Participants ("EPs") are required to download the available **Google Chrome for Windows version** from the following link **on 12 May 2025 during 9:00 a.m. to 12:00 noon Hong Kong Time** ("12 May Version").

EPs should pay attention to the followings:

1. Circular will be issued to notify EPs when they can start to install this 12 May Version;
2. Prior to installing the 12 May Version, EPs are strongly recommended to backup the Google Chrome installer of the Current Version. By keeping a backup of the previously-verified installer, EPs can ensure that a reliable and stable Google Chrome version is available at all times. This can help to minimize any disruption to EPs' trading activities; and
3. **EPs may not be able to login HKATS if the Google Chrome versions of their HKATS Online or HKATS Risk Functions are not complied with HKEX's requirement as prescribed from time to time.**
