Pursuant to the share consolidation timetable issued by GBA Holdings Limited ("GBA Holdings"), the share consolidation of 5 existing shares of HK\$0.04 each in GBA Holdings into 1 consolidated share of HK\$0.20 each will become effective on 19 March 2025. Shareholders, investors and market participants should read the GBA Holdings's circulars and regulatory announcements in full including the terms and conditions of GBA Holdings's share consolidation in dealing with GBA Holdings's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of GBA Holdings's OTP-C temporary stock page (stock code 2953) on 19 March 2025. Calculation of the Adjusted Previous Closing Price will be based on GBA Holdings's closing price on 18 March 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1

For illustration purpose, depending on GBA Holdings's closing price on 18 March 2025, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on GBA Holdings's OTP-C temporary stock page on 19 March 2025 as follows:-
