Pursuant to the share consolidation timetable issued by GOGOX HOLDINGS LIMITED ("GOGOX"), the share consolidation of 10 existing shares of US\$0.0000025 each in GOGOX into 1 consolidated share of US\$0.000025 each will become effective on 25 April 2025. Shareholders, investors and market participants should read the GOGOX's circulars and regulatory announcements in full including the terms and conditions of GOGOX's share consolidation in dealing with GOGOX's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of GOGOX's OTP-C temporary stock page (stock code 2971) on 25 April 2025. Calculation of the Adjusted Previous Closing Price will be based on GOGOX's closing price on 24 April 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on GOGOX's closing price on 24 April 2025, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on GOGOX's OTP-C temporary stock page on 25 April 2025 as follows:-
