Pursuant to the share consolidation timetable issued by China Parenting Network Holdings Limited ("China Parenting Network"), the share consolidation of 8 existing shares of HK\$0.05 each in China Parenting Network into 1 consolidated share of HK\$0.4 each will become effective on 13 May 2025. Shareholders, investors and market participants should read the China Parenting Network's circulars and regulatory announcements in full including the terms and conditions of China Parenting Network's share consolidation in dealing with China Parenting Network's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Parenting Network's OTP-C temporary stock page (stock code 2969) on 13 May 2025. Calculation of the Adjusted Previous Closing Price will be based on China Parenting Network's closing price on 12 May 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price
= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 8/1

For illustration purpose, depending on China Parenting Network's closing price on 12 May 2025, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on China Parenting Network's OTP-C temporary stock page on 13 May 2025 as follows:-
