Pursuant to the share consolidation timetable issued by FIH Mobile Limited ("FIH Mobile"), the share consolidation of 10 existing shares of US\$0.04 each in FIH Mobile into 1 consolidated share of US\$0.40 each will become effective on 20 May 2025. Shareholders, investors and market participants should read the FIH Mobile's circulars and regulatory announcements in full including the terms and conditions of FIH Mobile's share consolidation in dealing with FIH Mobile's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of FIH Mobile's OTP-C temporary stock page (stock code 2981) on 20 May 2025. Calculation of the Adjusted Previous Closing Price will be based on FIH Mobile's closing price on 19 May 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1

For illustration purpose, depending on FIH Mobile's closing price on 19 May 2025, the Exchange shall base on the above standard formula for share consolidation generally to calculate and display the Adjusted Previous Closing Price on FIH Mobile's OTP-C temporary stock page on 20 May 2025 as follows:-
