Pursuant to the share consolidation timetable issued by Universal Health International Group Holding Limited ("Universal Health"), the share consolidation of 10 existing shares of US\$0.01 each in Universal Health into 1 consolidated share of US\$0.10 each will become effective on 30 May 2025. Shareholders, investors and market participants should read the Universal Health's circulars and regulatory announcements in full including the terms and conditions of Universal Health's share consolidation in dealing with Universal Health's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Universal Health's OTP-C temporary stock page (stock code 2988) on 30 May 2025. Calculation of the Adjusted Previous Closing Price will be based on Universal Health's closing price on 29 May 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
