Pursuant to the timetable issued by BYD Company Limited ("BYD") for the final dividend, bonus issue and capitalisation issue of H shares (the "Dividend, Bonus Issue and Capitalisation Issue"), BYD's H shares (stock codes 1211 (HKD counter) and 81211 (RMB counter)) will be marked "ex-all" on 10 June 2025, the Ex-All Date. Shareholders, investors and market participants should read the BYD's regulatory announcements and circulars in full including the terms and conditions of the Dividend, Bonus Issue and Capitalisation Issue in dealing with BYD's H shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for ex-dividend and ex-bonus issue ("Ex-All") and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of BYD's OTP-C stock pages on 10 June 2025, the Ex-All Date. The unadjusted previous closing prices will instead be displayed in their free text fields. Calculation of the Adjusted Previous Closing Price will be based on BYD's closing price on 9 June 2025 (i.e. last cum-all trading day) and by using the following standard adjustment formula for dividend and bonus issue generally.

Adjustment Formula:

Adjusted Previous Closing Price

= [(Closing Price on the last cum-all trading day - D) x Y] ÷ (X + Y)

where:

D = Final Dividend per H share, i.e. RMB3.974

X = Number of new H shares a shareholder is expected to receive when he/she holds Y existing H shares on the record date, i.e. 20 new H shares

Y = Number of existing H shares a shareholder has to hold on the record date for entitling him/herself to X new H shares, i.e. 10 H shares
