Pursuant to the share consolidation timetable issued by China Silver Technology Holdings Limited ("China Silver Technology"), the share consolidation of 5 existing shares of HK\$0.001 each in China Silver Technology into 1 consolidated share of HK\$0.005 each will become effective on 16 June 2025. Shareholders, investors and market participants should read the China Silver Technology's circulars and regulatory announcements in full including the terms and conditions of China Silver Technology's share consolidation in dealing with China Silver Technology's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of China Silver Technology's OTP-C temporary stock page (stock code 2993) on 16 June 2025. Calculation of the Adjusted Previous Closing Price will be based on China Silver Technology's closing price on 13 June 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 5/1
