Pursuant to the share consolidation timetable issued by Eternity Investment Limited ("Eternity Investment"), the share consolidation of 10 existing shares of HK\$0.01 each in Eternity Investment into 1 consolidated share of HK\$0.10 each will become effective on 20 June 2025. Shareholders, investors and market participants should read the Eternity Investment's circulars and regulatory announcements in full including the terms and conditions of Eternity Investment's share consolidation in dealing with Eternity Investment's shares. If they are in doubt, they should consult their professional adviser(s).

As an OTP-C standard practice for share consolidation and for reference only, an Adjusted Previous Closing Price will be displayed in the "PRV CLOSE" field of Eternity Investment's OTP-C temporary stock page (stock code 2995) on 20 June 2025. Calculation of the Adjusted Previous Closing Price will be based on Eternity Investment's closing price on 19 June 2025 (i.e. the day immediately before the share consolidation becoming effective) and by using the following standard adjustment formula for share consolidation generally.

Adjustment Formula:

Adjusted Previous Closing Price

= Closing Price on the day immediately before Share Consolidation becoming effective x R

where:

R = Ratio of Share Consolidation, i.e. 10/1
